

## STATUTORY NOTICE – ECCLESALL/CLIFFORD CONSULTATION SEPTEMBER 2017

A consultation is currently underway regarding Clifford CE Infant School. Notice is given in accordance with section 19 (1) of the Education and Inspections Act 2006 that Governing Body of Clifford CE Infant School (Voluntary Aided) intends to make prescribed alterations to the school.

### **Proposal for Alteration of upper age limit by three years or more, Clifford CE Infant School (VOLUNTARY AIDED)**

Clifford CE Infant School, Psalter Lane, Sheffield, S11 8YU

The proposal is to create junior places for the children who attend Clifford Infant by changing the age range at Clifford Infant from children aged 4-7 to children aged 3-11 to become a through primary school. This would allow the 30 children per year who currently feed to Ecclesall CE Junior School to complete their primary education within one setting. Year 3 places would be offered at the school from 1<sup>st</sup> September 2018. The overall capacity of the school would increase to 210 pupils by September 2021. This proposal is linked to the proposal below. The purpose of this is to be able to offer all children a local school place.

### **Proposal for the Discontinuation of Ecclesall CE Junior School**

The Governing Body of Ecclesall Church of England Voluntary Controlled Junior School intends to discontinue Ecclesall Church of England Voluntary Controlled Junior School, Ringinglow Road, Sheffield, S11 7PQ. Ecclesall Church of England (Voluntary Controlled) Junior School is a 7-11 voluntary controlled junior school in Sheffield. The proposed date of closure is 31<sup>st</sup> August 2018. All children on roll at Ecclesall Church of England (Voluntary Controlled) Junior School on 31<sup>st</sup> August 2018 will be automatically allocated a place at Ecclesall Primary School (formally Ecclesall Infants School) on 1<sup>st</sup> September 2018.
